Sir,

On the subject and reference- 2, made at above the proposals towards amendment of the PPA to the billing of imported energy made by the Chief Engineer (IPC) to Telangana Electricity Regulatory Commission shall be agreed by us and as per the PPA 0.1% is for the auxiliary consumption on the installed capacity and SPDs enable for drawl of energy from DISCOM grid to maintain their

Further our concerns mentioned below for your reference.

- a. However, the Hon'ble TGERC issued Regulations No.1 of 2021 amending Regulation No.6 of 2016 with regard to billing aspect in the matter of net metering facility notifying that, "the quantum of electricity units exported by the eligible consumer shall be measured in KWh only.
- b. With reference to the above cited statement "a" the SPDs have raised monthly billing on KWh basis and the same has been followed since PPA made with the SPDs.
- We are importing power only for lighting and for maintaining DC and Communication system to SLDC during night and during plant shut down due to unavoidable like faults by grid and grid induced breakdowns and force majeure condition beyond our control
- d. SLDC has been asking to maintain communication on round the clock basis
- e. We have been successful and trying our best in limiting our consumption within the
- f. The Power factor variations and reactive power are due to grid issues and not attributable to



- g. We do not agree with TGSPDCL proposal for penalizing us by imposing HT tariffs for grid induced issues of power factor and reactive power and KVA based billing.
- h. It is therefore requested not to consider the amendment proposal of TGSPDCL for penalizing us with HT charges due to reasons not attributable to us as explained above and maintain status quo with present PPA as we have quoted our tariff for 20 years based on KWH based billing only and all imports are adjusted from delivered energy with quoted and we did not factor HT rates penalization in our tariff.

In view to above, we request you kindly.

- A. Please direct to Chief Engineer (IPC), TGSPDCL, Corporate Office, Mint Compound, Hyderabad to refund to us amount deducted as penalty against high MD/auxiliary recorded in the month of August & September' 24.
- B. Further, we will not accept the proposals before the commission seeking consent of amendment to the model solar PPA for billing of imported energy from the grid by the solar power developers.
