Sub: Objections / suggestions to the Public Notice regarding ARR filings and Tariff/Charges.

Ref: Public Notice issued by the TSSPDCL dated 10-03-2016, related to the filing of ARR and Tariff proposals including cross-subsidy surcharge proposals.

We introduce POULOMI HOSPITAL situated at A.S.RAO NAGAR SECUNDERABAD. managed by DR.CH.PARTHARSARDHI RAO (MS) MD of this hospital hospital was inaugurated in 2001 with 150 bedded with in built up area of 65000 sq ft. This hospital is having SICU,ICCU,CASULAITY, and many departments with reputed consultants with different specialties General Medicine, Cardiology, etc. we treat 75000 patients as outpatients and 15000 as in patients and 6000-7000 patients annually. The hospital is also approved by CGHS,AAROGYSRI,AAROGYA BHADRATA,BSNL and other categories provided treatment at authorized tariff prescribed by the government as per MOU. Patients who are in Intesive Care units requires continuous round the clock monitoring ventilator support and multi organ support.

Even inspite of the Generator and UPS backup frequent interruptions and voltage fluctuations in power supply became a serious problem and causes inconvience who are in ICCU.

I request you to consider the above factors into consideration in the light of recently (issued public notice dated: 10-03-2016) given by the southern power distribution company by telangana limited.

The following representations / requests made by the hospital may be considered before the review and proposed hike in the tariff.

- May I request you to shift the category from HT2 TO HT6 category with a preferential tariff.
- 2. Hospital works for 24/7 we humble request u a relief from time of day tariff.
- You are aware that large number of sick patients needs ventilators and monitors on 24 hours continuously uninterrupted power supply may cause hazardness to the patients.
