

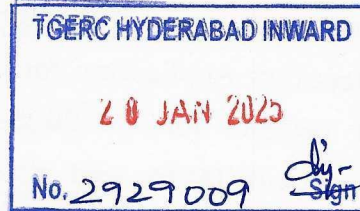

The Applicant respectfully submits the reasons for delay in filing the Annual Tariff Petition for FY 2025-26 for approval of Aggregate Revenue Requirement (ARR) and proposed revised Transmission charges of Transmission Business of TGTRANSCO as under:

1. A) As per the clause 6.2(e) of TGERC Regulation No. 2 of 2023 dated 30.12.2023, TGTRANSCO is required to file Annual Tariff Petition for FY 2025-26 for Transmission Business by 30.11.2024. TGERC has issued Tariff order for Transmission business for 5th MYT (FY 2024-25 to FY 2028-29) on 28.10.2024.

As the licensee has to study the Tariff Order for 5th MYT and prepare the Annual Tariff petition for FY 2025-26, and due to insufficient time between the date of Tariff order for 5th MYT and due date for filing Annual Tariff Petition for FY 2025-26, TGTRANSCO could not file the Annual Tariff Petition for FY 2025-26 for Transmission business by 30.11.2024.


2. In the aforesaid circumstances, the applicant respectfully prays the Hon'ble commission

- a) to take the Interlocutory Application for condoning the delay in filing Annual Tariff Petition for FY 2025-26 for approval of Aggregate Revenue Requirement (ARR) and proposed revised Transmission charges of Transmission Business of TGTRANSCO to consider the reasons mentioned under the circumstances submitted.
- b) To exempt payment of penalty, if any
- c) to pass such order, as the Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.
