Petition filed seeking determination of pooled cost of purchases for the FY-2023-2024 to be considered in FY-2024-2025.

Interlocutory Application filed for Condonation of Delay of 151 days (number of days not mentioned in Application).

Sri. Mohammad Bande Ali, Law Attaché being the representative of the petitioner appeared before the Commission and requested to condone the delay of 151 days. The representative of the petitioner stated that the delay has occasioned contrary to the orders of the Commission due to delay in obtaining audit reports. The Commission observed that in terms of regulation relating to penalty payable for delayed filing of the petition. The representative of the petitioner agreed to comply with the payment of penalty. The Commission further observed that the filing is incomplete without enclosing the audit reports which had resulted in delayed filing. Therefore, it has directed the representative of the petitioner to file the audit reports for enabling the Commission to decide the matter. Subject to filing of audit reports the petition and the interlocutory application stand reserved for orders in terms of Regulation No. 7 of 2022.

Petition filed seeking consent to the amendment to the power purchase Agreement dated 19.02.2020 vide. Amendment Agreement dated 10.10.2022 duly enhancing the capacity of the project from 19.8 MW to 24 MW.

Sri. Mohammad Bande Ali, Law Attaché being the representative the petitioner and Sri. Matrugupta Mishra Counsel for the respondent along with Sri. Nipun Dave, Advocate have appeared in the matter. The representative of the petitioner stated that the matter posted pursuant to order passed by the Hon'ble ATE duly remanding the matter back to the Commission. The Counsel for the respondent while

conforming the orders of the Hon'ble ATE requested the Commission to provide with the entire record relating to the petition filed by the petitioner herein including the inspection reports obtained by the Commission or placed before it prior to order dated 31.10.2023. As otherwise it is not incumbent upon the respondents to advert to the contentions in the matter. Also, he stated that if all the material is available to the respondent he would be able to present a detailed submissions in the matter, for this purpose the respondent needs time of 5 weeks to file its counter affidavit as also all the relevant documents. To the suggestion the matter be taken up on 11.11.2024, counsel for respondent urged the Commission to post the matter to any other date other than 11.11.2024. Accordingly, acceding to the request of the counsel for respondent, the matter is adjourned. Office is directed to provide entire set of the record to the counsel for respondent subject to payment of photocopying charges.
