

Sub: Filings made by TGSPDCL and TGNAPDCL on Determination of ARR & Wheeling Tariff of Distribution Business for 5th Control Period (FY 2024-25 to FY 2028-29) – O.P Nos 12 of 2024 and I.A Nos 11 of 2024

Referring to the subject cited, this is to bring to the notice of the Hon'ble Commission that, the said filing are not yet uploaded on the websites of either TGERC or on TGSPDCL. The advertisements that came in today's major newspapers such as Eenadu, The Hindu and Deccan Chronicle consists of only the schedules on ARR for FY 2024-25 to 2028-29, Wheeling Tariffs and Wheeling Losses for 5th Control Period and filing of proposed Tariffs for TGDISCOMs for FY 2024-25.

Since the availability of information is delayed by one day (working hours), and keeping in view the Dasara Festival from October 2nd (Dasara Navaratrulu) and 11th October, the last date for submission of comments and objections is a festival day, we request the Hon'ble Commission to extend the last date for submission of comments.

TG Transco also has filed the ARR and proposed charges for Transmission Business and SLDC for FY 2024-25 to FY 2028-29 and the last date for submission of the comments is again 11/10/2024.

Keeping in view the enormity of the work and the festival days, we request you to extend the last date for submission of comments by 10 working days, i.e. from 11th October to 24th October 2024.

Your positive consideration will give sufficient time to the objectors to provide meaningful objections on the filings of TG Transco and TG DISCOMs.
