Sub: Petitions filed by Telangana Electricity Utilities – TG DISCOMs, TS Transco, TS Genco – for 5th MYT period – request for extension of last date for submission of comments / objections - reg

Telangana Utilities have filed several important Petitions in respect of ARR/ Tariff before TGERC, which are as under:

1. Telangana Northern DISCOM: ARR for the 5th MYT (FY 2024-25 to FY 2028-29), FPT for FY 2024-25, and CSS for FY 2024-25.
2. Telangana Northern DISCOM: ARR & Wheeling charges for the 5th control period (FY 2024-25 to FY 2028-29).
3. Telangana Southern DISCOM: ARR for the 5th MYT (FY 2024-25 to FY 2028-29), FPT for FY 2024-25, and CSS for FY 2024-25.
4. Telangana Southern DISCOM: ARR & Wheeling charges for the 5th control period (FY 2024-25 to FY 2028-29).
5. Telangana Transco and SLDC: Transmission Business and SLDC activities of TGTRANSCO for the 5th MYT (FY 2024-29).
6. Telangana Genco: True-up for FY 2022-23 and MYT for FY 2024-29.

The last date for receiving comments / objections from the stakeholders for all these filings is mentioned as 11th October 2024.

This is to submit that it is highly difficult and impractical to submit the comments in such a short period of time, more so as it is coinciding with Dasara festival.

We could not comprehend the reasons for giving such a short notice to the stakeholders to submit their suggestions; that too for studying 5th MYT Petitions of all three utilities by the Hon'ble Commission.
