Sub:- TSSPDCL – IPC - 2<sup>nd</sup> Amendment to PPA dated 17.09.2019 towards extending the validity of the agreement period of 2 Nos TSGENCO Thermal plants, RTS-B (62.5MW) for a period of 1 year and KTPS-V (500 MW) for a period of 5 years – Request for consent - Reg.

In respect to the subject matter, it is to submit that, a common Power Purchase Agreement (PPA) dated 22.12.2009 was entered by erstwhile APGENCO with the four DISCOMs of United Andhra Pradesh for all Thermal and Hydel Stations which were commissioned between 1956 to 2004 and the said PPA was expired on 31.03.2019.

After expiry of the Common PPA, a PPA was entered on 17.09.2019 between TSGENCO and TSDISCOMs for 100% sale of power to TSDISCOMs for all thermal and Hydel Stations owned and operated by TSGENCO which were commissioned between 1956 to 2004 with the Terms & Conditions as per provisions of TSERC Regulations.

Subsequently, the Hon'ble TSERC in the order dated: 06.08.2021 in O.P. No.16 of 2021 accorded consent to PPA dated 17.09.2019 (Suo-Moto approval) subject to amendments in certain clauses and Articles of the PPA.

Accordingly, the PPA was amended on 22.12.2021 for Thermal and Hydel Stations of TSGENCO (commissioned between 1956 to 2004) by carrying out the modifications as per TSERC order wherein the validity of PPA of Thermal Stations KTPS-V (500 MW) and RTS-B (62.5 MW) are going to expire on 31.03.2024.

Hence, both TSDISCOMs have entered the draft 2<sup>nd</sup> Amendment to PPA dated 17.09.2019 extending the validity of the agreement period of 2 Nos TSGENCO Thermal plants, **RTS-B (62.5MW) for a period of 1 year and KTPS-V (500 MW) for a period of 5 years.**

In this regard, the draft 2<sup>nd</sup> Amendment with signatures in respect of RTS-B (62.5MW) & KTPS-V (500 MW) is herewith enclosed for according consent of the Hon'ble Commission.



- 500063 (hereinafter referred to as "TSSPDCL") and Northern Power Distribution Company of TELANGANA Limited. (Eschile APNPDCL constituted under the sub-section (6) of section 23 of Andhra Pradesh Electricity Reform Act, 1998) constituted as per the provisions of AP Re-Organisation Act, 2014, having registered office at H.No.2-5-31/2, Corporate Office Vidyut Bhavan, Nakkalagutta, Hanamkonda, Warangal - 506001 ("TSNPDCL"); (hereinafter each of TSSPDCL, TSNPDCL are, as the context may require, individually referred to as "TSDISCOM" and collectively referred to as the "TSDISCOMs" which expression shall, unless it be repugnant to the context or meaning thereof include its successors and assigns), as parties of the first part, and
2. TELANGANA STATE POWER GENERATION CORPORATION LIMITED, constituted under Companies Act, 2013 on 19th May 2014 and as per the provisions of AP Re-Organisation Act, 2014, and commenced its operations from 02.06.2014 having its registered office at Vidyuth Soudha, Hyderabad - 500082 (hereinafter called "TSGENCO") which expression shall, unless repugnant to the context or meaning thereof include its successors and assigns, as party of the second part and will be submitted to Hon'ble TSERC.
  3. Whereas, the Original Power Purchase Agreement (PPA) dated 17<sup>th</sup> September 2019 was entered between the aforesaid parties for purchase of all the declared capacity and energy by TSDISCOMs on long term basis from the TSGENCO owned and operated Thermal & Hydel Power Stations as mentioned in Annexure-I of original PPA Dt: 17.09.2019.
  4. Whereas, the Hon'ble TSERC in the matter of Suo-Moto approval of PPA dated. 17<sup>th</sup> September 2019, under order dated. 06.08.2021 in O.P.No. 16 of 2021 accorded the consent to the PPA, subject to amendments in certain clauses and Articles of the PPA dated 17.09.2019 and directed the TSDISCOMs to submit the PPA duly incorporating changes for the record of the Commission.
  5. Whereas, as per the directions of Hon'ble TSERC 1<sup>st</sup> Amendment PPA was entered between TSGENCO & TSDISCOMs on Dt: 22.12.2021.
  6. Whereas, as per Annexure-I Table 1(a) the validity of PPA in respect of RTS-B & KTPS-V stage is up to 31.03.2024. Hence 2nd Amendment is entered extending the validity of PPA of RTS-B & KTPS-V stage as detailed in the Annexure-I Table 1(a).
